Completely filled electronic Bid document with necessary supporting documents must be submitted through website [www.bolpatra.gov.np/egg](http://www.bolpatra.gov.np/egg) on or before 12:00 of 31st day from the date of first notice published. Documents received after this deadline shall not be accepted.
4. Bids shall be opened in the presence of Bidders' representatives who choose to attend at 31<sup>st</sup> day from the date of publication at 14:00 hours at the Office of the Chief Minister and Council of Ministers, Butwal, Nepal.
5. Bids must be valid for a period of 90 **days** counting from the day of bid opening and must be accompanied by bid security of minimum amount as specified in above table, cash deposit in Account No.: 3120 2020 00001, Rastriya Banijya Bank, Butwal Branch or in the form of unconditional Bank guarantee from A class Bank in favor of Office of the Chief Minister and Council of Ministers, Rupandehi, Nepal which shall be **valid for minimum 30 days** beyond the bid validity period.
6. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
